## PUBLIC NOTICE OF PENDENCY OF APPLICATION FOR TARIFF REVIEW FOR THE LIBERIA ELECTRICITY CORPORATION (LEC)

The Liberia Electricity Regulatory Commission (LERC) hereby notifies the public that an application for the Review of Electricity Tariff has been filed by the Liberia Electricity Corporation (LEC) and is pending before the Commission. The approved tariffs shall take effect on January 1, 2026.

The LERC is issuing this Notice of Pendency of Application for the Review of Electricity Tariffs and is undertaking this Tariff Review exercise pursuant to Section 13.7 of the 2015 Electricity Law of Liberia, the Electricity Tariff Regulations of May 4, 2021, and LERC's Administrative Procedure Regulations of September 2020.

The Schedule for deciding on LEC's tariff application is as follows:

- Interested parties are invited to make submissions in writing to the Commission at its office D-1436 Tubman Boulevard, Adjacent NASSCORP 24th Street, Sinkor, Monrovia, Liberia or via email (<u>info@lerc.gov.lr</u>) from October 14-24, 2025 of the publication of this notice;
- 2. There shall be public hearings on LEC's application in Bomi (Tubmanburg) on October 24, 2025; Grand Cape Mount (Robertsport) on October 25, 2025; Grand Bassa (Compound #1) on October 30, 2025; Rivercess (Yarkpa Town) on October 31, 2025, Margibi (Kakata) on November 6, 2025; and Montserrado (Monrovia/Paynesville) on November 19, 2025 respectively. These public hearings shall commence at 10:00 a.m. on the respective dates where LEC shall present its tariff proposal and interested parties may attend and make oral submissions. The Commission will announce specific venues for each of the public hearings in the various locations; and
